From the North: I-74S, Take exit 24 for US-220 Alt toward Candor & turn left at end of ramp onto US Hwy 220 Alt S. In 1/2 mi take slight left on Windblow Rd. In 2 mi Turn left onto Belford Church Rd. Club House & Hunt Test grounds will be 3 mi on the left.

From the South: I-74N, Take exit 33 for NC 73 & turn right at end of ramp onto Rt 73 E. In 6 mi turn left onto Jackson Springs Rd. Club House & Hunt Test grounds will be about 1 mi on the right.

From the East via Pinehurst, NC: Use NC 211 N thru Pinehurst for 5 mi. Turn Left onto NC 73 W at West End. In 5 mi turn right onto Jackson Springs Rd. Club House & Hunt Test grounds will be about 1 mi on the right.

From the West: Take best route East to I-74 & follow directions above from either the North or South.

## Attention Exhibitors

1. TRACKING DEVICES ARE NOT ALLOWED
2. BITCHES IN SEASON ARE NOT ALLOWED ON GROUNDS
3. Hunting tests are open to all Pointing Breeds six months of age or over on the first day of the event that have been individually registered with AKC or individually registered with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration.
4. Hunting Tests are also open to pointing breeds enrolled in the Foundation Stock Services (FSS) program that have been granted approval to participate in Pointing Breed Hunting Tests. .
5. Dogs from eligible breeds that have been granted Purebred Alternative Listing (PAL, formerly known as ILP), limited registration, conditional registration and spayed or neutered dogs, shall be eligible to enter in Pointing Breed Hunting Tests.
6. Bitches who come in season after entries close shall be refunded in full, subject to receipt of Veterinarian certification within 24 hours following the Hunt Test.
7. No refunds for inclement weather or other conditions beyond the control of CISC
8. North Carolina law requires that participants age 16 and over must have a valid NC hunting license (or a valid license from their own state) in their possession
9. AN ACCEPTABLE ARTICLE OF BLAZE ORANGE CLOTHING MUST BE WORN BY HANDLERS AND GALLERY DURING ALL TESTS
